

We are pleased to give Bounty hunters a chance to earn decent money with us. All money earned here is represented in real stablecoins. These tokens will not fall in price at all.

1. To be eligible for receiving tokens, the participant must pass Captcha.
2. If a participant passes all checks, 3% of tokens will be transferred to their exchange account every week after pressing the "Withdraw" button. This is done for your safety and convenience. You will then immediately be able to sell tokens, if you wish.
3. The withdrawal button will work every day, however, each 3 percent of funds that follow will be unlocked once a month, only after approving your balance on the platform they will be unlocked on the 1st day of each month. Funds will be transferred to your account, into your TRC-20 wallet, every Monday.

Important notice: please be aware that your account on the exchange must be registered exclusively under the same email address as your account on the bounty platform!

***Please note that if your funds were approved on the platform only in April, for example, then the first percentage of the unlock will be on May 1**

***Please note our team is not responsible if a user provides the wrong wallets address.**

All the above rules apply to users who do not have KOREAN or JAPANESE numbers.

FOR JAPANESE AND KOREAN PARTICIPANTS

Due to the focus of our Campaign being on Japanese and Korean Communities, the rules for users from Korea and Japan will be different. Japanese and Korean participants will be able to withdraw their funds from the bounty platform, anytime starting from 31st of March, 2020 - the further out lock-up periods for these users will not apply.

In order to withdraw the whole amount of your earned rewards please, connect your Telegram account that has your Japanese or Korean phone numbers, with your bounty platform account, then follow the steps below:

1. The "Withdraw" button will appear on your dashboard after the end of the Bounty campaign. You'll be able to withdraw your bounty tokens starting from the 31st of March, 2020.
2. Please make the withdrawal request by clicking the "Withdraw" button on your account, on the bounty platform.
3. Funds will be transferred to your TRC-20 wallet, every Monday.
4. Minimum withdrawal amount 10 USDQ

Disqualification rules

Please read the rules listed below thoroughly! Ignorance of any rules leads to the rejection of a submission:

1. Participants must check our announcements and updates on a regular basis, in order to stay informed of any changes.
2. If a participant is removed from the campaign, their tokens are removed as well.
3. Any manipulations with fake accounts will automatically lead to a permanent ban for the rule-violating participant.
4. Floods of messages and any amount of meaningless messages could also result in a ban for the rules violator.
5. Spamming and advertising of projects that are unrelated to the projects are strictly prohibited!

Additionally, if you find any bugs, issues or any kind of technical error, you must declare this matter straight away. Of course, our team will reward you for your great contribution to the development of our project!

In the serious instance of any cheating using fake bugs, the violator will be immediately banned, without any chance of recovery.
